1. Order form duly filled in shall be sent to Mint along with full payment in advance by Demand Draft payable at Mumbai on any Scheduled Bank issued in favour of “**INDIA GOVERNMENT MINT (UNIT OF SPMCIL) COLLECTION A/c.**”. All payments shall be in whole rupee and payments in paise will not be accepted. Cheques will not be accepted.
2. Orders can be placed directly by Foreign Nationals against advance payment in U S Dollars. Separate order form is available on website www.mumbaimint.in. The above cost is inclusive of Tax/VAT, Excise Duty and Postage charges.
3. The coin sets can also be booked online on our website www.mumbaimint.in

Booking Period : From **02/05/2012 to 30/06/2012**

Delivery : Approximately 9 months from closure of booking.

NOTE:

1. All remittance shall be in whole rupee only in case of booking in India and US \$ for out of India.
2. All transactions are subject to “Mumbai Jurisdictions”.
3. Orders once accepted cannot be cancelled under any circumstances and shall be collected within a period of three years. **Claim after three years from the closure of booking will not be entertained.**
4. The Mint reserves the right not to accept an order either in whole or in part.
5. Only Mumbai Mint will sell these Proof & Uncirculated coin sets.
6. The purchase of these coin sets will not bestow permission for export thereof, which is regulated by special order issued from time to time.
7. The Mint reserves the right to extend or discontinue or stop booking of coin sets without any notice depending upon the production capacity and the price of metal etc.
8. The Mint will make efforts to deliver all coin sets booked as per delivery schedule. However, due to unforeseen reasons if the delivery is affected and delayed the mint reserves the right to extend delivery period.
9. The Mint will not be responsible for the delay or loss of the coin sets dispatched by post and the claim for substitute coin sets will not be entertained unless and until the postal authorities refund the insured amount.
10. The dispatched parcel if returned by the postal authorities will be re-dispatched only on receipt of fresh postal charges.
11. Changes in duty & taxes will be on actual.
12. Any change in delivery address should be informed immediately to the Mint by the subscriber/person booking the coin.
13. Hand delivery cannot be made since entry of the persons to the Mint is restricted to the barest minimum due to security reasons.
